#### Terms and Conditions

**Deposit** A booking and administration deposit of \$300 is required from the renter at the time the renter books the trailer for a rental period. This deposit is required before a booking is confirmed. Payment can be made by cash, cheque (made payable to KDR Transport & Rentals) or e-transfer (made to kdrtransportandrentals@gmail.com).

At the commencement of the rental period, the booking and administration deposit will be transferred to a damage deposit, in the case of damage while the trailer is in your possession.

After the return of the trailer, an inspection will be completed and the damage deposit will be refunded by e-transfer within approximately 72 hours, providing the trailer is returned by the time specified on this contract, clean and in good condition.

If for any reason the trailer is not available for the time reserved, KDR Transport & Rentals is liable to the extent of the deposit only.

**Refund Policy** If the renter cancels the booking at any time in advance of the commencement of the lease, all or any portion of the rental period, the following refund policy shall apply:

- If notice of cancellation is received more than seven days in advance of the rental date, 50% of the booking and administration deposit will be refunded
- If notice of cancellation is received seven days or less in advance of the rental date, there will be no refund of the booking and administration deposit
- No refund is given for early returns

**Prohibited Use** The trailer of this contract will not be used:

- a. By anyone not specifically named in this agreement;
- b. By anyone whose ability to operate the tow vehicle is impaired by alcohol, drugs or fatigue;
- c. Outside of Ontario without written consent;
- d. In any contest;
- e. At any music festival or sporting event;
- f. In violation of any law.

**Damage/Injury** The renter is responsible for all loss, damage and/or mechanical repairs to the trailer and any accessories, regardless of fault, resulting from abuse, misuse or negligence.

The renter agrees to pay a sum equal to the regular daily rental rate of the trailer for each day the trailer is unavailable for rent while any damage and/or mechanical repairs are made.

The renter is entirely responsible for all damages.

KDR Transport and Rentals is not liable for the death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me or my associates.

KDR Transport and Rentals is not responsible for any and all liabilities and claims made by other individuals or entities as a result of any of my actions or the actions of my associates.

**Reporting of Accidents and Theft** The renter will report any accident or theft involving the trailer to the police and shall complete a written report as soon as possible and in any event within 24 hours.

**Tickets or Fines** The renter will pay all fines and other costs associated with traffic and parking violations issued during the rental period. The renter is responsible for any charges from the 407 or any toll road costs while in possession of the trailer.

**Personal Property** KDR Transport & Rentals is not responsible for loss or damage of any property left in, upon or carried in the trailer.

**Loads** The renter agrees to pay for any and all damage and/or mechanical repairs resulting from the trailer being overloaded, improperly loaded, resulting from an insecure load or used outside of its intended purpose.

**Licenses and Permits** Any additional licenses or permits required by provincial authorities are the responsibility of the renter.

**Tow Vehicle** All tow vehicles must have a Class 2 or better hitch. Tow vehicles are not covered by KDR Transport and Rentals' insurance. If a trailer is damaged by a tow vehicle, the renter is responsible for all damage, loss of use and towing fees.

**Awnings** The use of awnings, if applicable, is the sole responsibility of the renter. If you decide not to use the awning, please leave it retracted in the upright position. There is a zero tolerance for damaged awnings. If the awning becomes damaged during your use, you will pay for the repair. After each trailer is returned and before it is sent out again, all awnings are checked and inspected. Repairs are executed when the damage is found. This ensures that the awning is in working order and damage free for your holiday. It also enables us to bill the damage of the responsible renter. If you choose to use the awning, please use it safely and responsibly. If you choose to use the awning, please ensure that it is high enough so that the door does not rub.

**Smoking and Pets** Smoking is not permitted in the trailer. Do not allow friends or visitors to smoke in the trailer or you will be responsible for the cleaning charges. If there is evidence of smoking in a trailer, there will be a \$300 cleaning charge.

Pets are permitted in the trailer; however, the renter is responsible for any damage caused by any pets. The trailer must be returned clean and there will be a fee of \$300 should there be any evidence of pets found upon return of the trailer.

**Car Trailer/ Enclosed Trailer** The renter agrees that any car trailer or enclosed trailer will be towed only by a vehicle with a drop hitch (due to the back of the trailer being low to the ground).

The renter must disclose what the trailer is being used for prior to renting.

**Travel Trailer** Renter is responsible for emptying the holding tanks prior to returning the trailer. Renter must follow instructions re the emptying process. If the tanks are not emptied, there will be a fee of \$100.00.

**Return of Trailer** If the renter returns the trailer to any location other than the renting location, the renter agrees to pay the regular rates plus any additional towing charges.

All equipment must be returned with the trailer.

Please return the trailer in a tidy condition to avoid extra charges. A cleaning fee will apply for any trailer not returned in this condition.
